K. Narkhede College, Bhusawal and Smt. P. K. Kotecha Mahila Mahavidyalaya, Bhusawal desire to prevalence and development of academic and research activities between two institutions and have agreed to sign and enter into MoU as follows:

1. Objectives:

- A) To provide a common forum for exchange of ideas & views regarding the execution of academic and research programmes.
- B) To use & share libraries, laboratories, database, documentation, instrumental and related infrastructure of each other.
- C) To exchange the information, arrange joint seminars / conferences / symposia / workshop, Exam etc.
- D) The prevalence of science and technology among the students of both the institution.

2. Activities and programmes:-

The institution based upon the principle of respect of each other's independence and of mutual benefit, will carry out following activities:-



- i) Co-operation of Teachers in Examination
- ii) Exchange of publication and information
- iii) Joint research activities
- iv) Sharing of laboratory and Library facilities

3. Formulation of plans:-

In order to carry out the above activities, detail plans shall be formulated after the Consultation between the two colleges time to time depending upon the nature and need of specific activity, availability of funds and convenience of both the colleges. However, the basic principal shall be mutual co-operation and academic benefit of students and faculties of both colleges.

4. Financial terms and mode of payment if any:-



The requirement of funds for these activities – programmes shall be worked out through mutual consent between K Narkhede college, Bhusawal & Smt. P.K. Kotecha Mahila college, Bhusawal shall not demand any monetary charges from each other for the use of technology and know-how developed for their own internal use for the purpose of teaching, training, prevalence of scientific programs, research and development.

5. Dissemination of data and information:-

K Narkhede college, Bhusawal & Smt. P.K. Kotecha Mahila college, Bhusawal shall work out the modalities for dissemination of research data to any third party keeping in mind the mutual academic interest. However, both parties shall fulfil their obligation of disseminating the data to national databanks, as required by concerned funding agencies.

6. Coordination Committee:-

A joint co-ordination committee for smooth and effective execution of activities and programmes under this MoU shall be formed mutual consent.
